### A MESSAGE FROM THE

## Windsor Township Board of Supervisors

2020 has not been a typical year so far! It started with a winter where there were only a few snow and ice storms. Then came COVID-19 with its Stay-at-Home orders, quarantines, school cancellations, travel restrictions and shortages of masks, hand sanitizer, antibacterial soap, and toilet paper. The grocery stores are still struggling to keep shelves stocked. Several annual Township sponsored events such as electronics collection and Community Volunteer Day were cancelled.

COVID-19 doesn't appear to be going away any time soon as new cases continue to be reported across Pennsylvania and the rest of the country.

But good things happened in 2020. On May 30th, the Space X Crew Dragon spacecraft successfully launched with Astronauts Bob Behnken and Doug Hurley onboard. This was the first crewed orbital spaceflight launched from the United States since the final Space Shuttle mission in 2011. After 2 months at the International Space Station, the Crew Dragon splashed down in the Gulf of Mexico on August 2nd marking the first water landing since 1975.

The Comet Neowise appeared in early July. The comet was visible to the naked eye in the night sky. If you missed it, you will have a while to wait as it won't be seen again for another 6,800 years.

We will just have to sit back and wait to see what the rest of the year brings.

### **EAGLE SCOUT PROJECT**

#### CREDIT CARDS BEING ACCEPTED FOR PAYMENT OF QUARTERLY SEWER BILLS

### **Problems at Sewer Pump Stations**

With the COVID-19 pandemic, more people are staying at home. Along with this, families are preparing meals and using disposable wipes to sanitize areas of their homes. This has posed problems at the Township sewer pump stations.

We have noticed that more grease is accumulating in the pump stations. You can help by not pouring grease down the drain. Cooking oil and grease should be poured into a heat resistant container and disposed of, after it cools off, in the garbage.

There has also been an increase in clogs involving disposable wipes. Even though the containers for the wipes say that they are flushable, they do not deteriorate quickly. They become lodged in the pumps which prevent the pumps from working properly.

Your help with both of these issues is greatly appreciated!

### **Community Center Update**

The design of the proposed community center and athletic fields, to be located on the former Spring Valley Pool property on Lombard Rd., is almost complete. The proposed community center building will feature a multi-use gymnasium, social hall, kitchen, classrooms, batting cages and more. Soccer fields, tether ball, basketball courts and a tennis court are just some of the outside amenities that are being proposed.

In 2018, the Township submitted an application for grant funding from the Redevelopment Assistance Capital Program (RACP) in the amount of \$3,000,000. With the help of an endorsement from Representative Stan Saylor, our application was accepted and the community center project has been listed on the State's Capital Budget. In August of this year, the Township submitted an application to receive funding in the amount of \$3,000,000. It is anticipated that we will find out whether the Township will receive the funds in early 2021.

### Pennsylvania Yellow DOT Program



The Yellow DOT Program was created to assist citizens in the "golden hour" of emergency care following a traffic accident when they may not be able to communicate themselves. Placing a yellow dot in your vehicle's rear window alerts first responders to check your glove compartment for vital information to ensure that you receive the critical medical attention you need.

### **POLICE REFORM**

A lot has changed since the last newsletter was published. A lot may have changed since writing this newsletter and before it is published in the Fall of 2020.

Police reform bills have been introduced and some passed at the time I'm writing this newsletter, which is in the first week of August, to provide limitations, training, databases and loosen restrictions on personnel files for police departments throughout the Commonwealth.

Many of these reforms are supported and encouraged by the police administrators and the officers themselves to better our profession. One example that is supported by police chiefs and administrators is the ability for the police departments to disclose, in good faith, information regarding a former police officer who may have left employment under unfavorable conditions. This change in the law allows the departments to disclose personnel information, without fear of civil liability, to any new prospective police department employers.

The other reforms that have recently passed or been drafted as bills have not been of a concern to the York Area Regional Police Department as they already comply with the language contained in the bills. The Police Department has achieved accreditation status from the Pennsylvania Law Enforcement Accreditation Commission since 2008. Each year the Department must show compliance with the standards set forth by the Commission; the Department is then audited every 3 years to ensure compliance with the 135 standards.

The accreditation process provides accountability, an independent review of police operations, and feedback to improve procedures and processes to enhance the delivery of police services to the citizens of our communities. I commonly refer to this process as Professionalism in Policing. There are 18 police departments in York County and currently 7 departments have achieved accreditation status.

District #2 - Red Lion Bible Church - Springvale Rd.


District #3 - Laurel Fire Company - Schoolhouse Ln. off N. Penn Street in Windsor Borough

### **BODY CAMERAS**


The Police Department has recently purchased body-cameras for the officers to wear while on patrol and during the normal course of their daily activities. These cameras were purchased as part of a grant applied for on behalf of numerous police departments throughout the Commonwealth by the Pennsylvania Chiefs of Police Association. The grant is allocated through the PA Commission on Crime and Delinquency which provides the funding from the Byrne Justice Assistance Grant.

The Police Department's patrol vehicles are outfitted with in-car cameras, dash-cameras, and the body-worn cameras will sync and interact with both in-car cameras and body cameras to capture audio and video footage for each incident that the officers respond to during the course of their day.



### **DAILY POLICE BLOTTER**

The Police Department has implemented a daily police blotter on our website for the daily calls received by the Department for each municipality. This provides a general description of the call, date, street location, report number (lognum), criminal offense code (UCR Code). Traffic stops are not logged on this report as this only pertains to calls for service or criminal offenses that the officers generate a report.



### **BUILDING PERMITS**


Building Permits are required for most projects. Contact the Township Office at 244-3512 if you have a specific project upcoming. Keep in mind that there is a lead time for getting certain types of permits. Plan ahead!

### COMPACT FLUORESCENT LIGHT (CFL) BULB RECYCLING

Just a reminder that CFL bulbs can still be brought to the Township Office for recycling. Bring your unbroken CFLs to the Township Office during normal business hours and we will take it from there. Sorry, we cannot accept tube fluorescent bulbs. This is only for CFL bulbs.

### SHREDDING EVENT

The Township will again be sponsoring a shredding event on Saturday, November 21, 2020 from 9:00 a.m. to Noon at the Township Office located at 1480 Windsor Rd., Red Lion. This event is a free event for Township residents only. NO BUSINESSES. There is a two (2) box limit. A box is defined as 18 inches long/9 inches high/12 inches wide.



### **SPRING LEAF COLLECTION**

The Township will hold a spring leaf collection program again next year. It will run from April 19, 2021 through April 30, 2021. All aspects of the fall collection will apply during the spring collection.

### LEAF COLLECTION

Leaf collection will run from October 12, 2020 through December 11, 2020. The Township uses a leaf collector that is self contained and is operated by one person. This eliminates the need for rakers. Remember to rake leaves as close to the edge of the blacktop/curb as possible in narrow rows away from fences, posts, poles or cars. Tree limbs, grass, shrubs and hedge trimmings, bricks, stones or any foreign objects are **not** to be deposited in the leaves. If foreign objects are found, the leaves will not be collected.

## **Garbage and Large Item Collection**

Just a reminder that there is a four (4) bag/container limit on your weekly trash service. Each bag/container, when filled, may not weigh more than 75 lbs. nor exceed a volume of 32 gallons. If you are using a toter supplied by Republic Services, the toter is considered 3 bags of garbage. Therefore, you can put out a toter plus one (1) bag of garbage.

## When there is a holiday on a weekday, collection will be one day late after the holiday. The holidays observed by Republic Services are:

New Years Day Memorial Day July 4th (if it is a weekday) Labor Day Thanksgiving Christmas Day

For example: Thanksgiving Day is a Thursday. Therefore, the regular Thursday collection will take place on Friday and the regular Friday collection will take place on Saturday.

Residents are permitted to put out **one (1) large item per week** as part of their regular trash collection. All items must be out at the curb by 6:00 a.m. on your regular trash collection day. It is suggested that items be placed at the curb the night before your collection day. **Please contact the Township Office at 717-244-3512 by 4:00 p.m. the day before your collection to inform us you will be putting a large item at the curb.** 

#### THIS COLLECTION DOES NOT APPLY TO THE TOWNHOUSES IN WINDSOR COMMONS APARTMENTS AND LION'S GATE (FORMERLY WINDSOR POINTE).

### ITEMS WHICH <u>WILL</u> BE COLLECTED PER HOUSEHOLD:

- a. Furniture (sofa, chair, etc.)
- b. White goods (stove, water heater, etc.)
- c. Carpet rolled, tied in 4 ft. lengths
- d. Mattresses & Boxsprings (Must be wrapped)
- e. Car tires only, **must be <u>off rims</u>**. (No large truck tires)

### ITEMS WHICH **WILL NOT** BE COLLECTED:

- a. Construction debris (drywall, tile, shingles, bricks, etc.)
- b. Batteries and automobile parts
- c. Treated lumber & roofing shingles
- d. Hazardous materials (Pesticides, propane tanks, etc.)
- e. Tree stumps and other woody waste
- f. Electronics

REMEMBER: Due to the "Covered Devices Act", electronics will not be collected as part of our trash/large item collection program. They cannot be disposed of at Pennsylvania waste disposal facilities. They must be recycled through an approved recycler or recycling program. Please see the article in this newsletter on electronics recycling.

### ON-LOT DISPOSAL SYSTEM (OLDS) MANAGEMENT PROGRAM

Earlier this year residents within District #4 were notified of their requirement to comply with the OLDS Management Ordinance. District #4 covers all properties served by on-lot septic systems west of Freysville Rd. and north of Red Lion Borough. If you received a notice and have not yet taken steps to have your system pumped/ inspected and if necessary, brought to full ordinance compliance, please do so prior to the end of the year. If you have questions as to whether you have complied, please contact the Township office to verify; noncompliance will result in penalties.

## Woody Waste Drop-off and Curbside Collection

The Township is still offering a drop off location for woody waste. The woody waste drop off will take place the 2nd Saturday of selected months from 8:00 a.m. to 11:00 a.m. at the Public Works Building located at 970 White Oak Rd., Windsor. The drop off dates for the rest of 2020 and all of 2021 are as follows:

September 12, 2020 October 10, 2020 December 12, 2020 March 13, 2021 April 10, 2021 June 12, 2021 July 10, 2021 August 14, 2021 September 11, 2021 October 9, 2021 December 11, 2021

The drop off is for residential woody waste only. Our employees will be on hand to assist with unloading the woody waste. **This service is available to Township residents only. Photo identification will be required.** There is a six (6) ft. length limit as well as a six (6) inch diameter limit. Woody waste brought to the drop off location does not need to be bundled. **NO commercial businesses. NO grass clippings, tree stumps, sawdust, mulch, flower debris or bagged debris.** 

The Township will continue to provide a **curbside woody waste collection** during the months of May and November. The next curbside collection is scheduled for the week of November 2, 2020 on the same day as your regular trash collection. The dates of the spring curbside collection will be announced after the first of the year. These collections will deal with brush and tree trimmings only.

- The trimmings must be **bundled and tied with twine** in 4 ft. lengths or placed in a biodegradable bag. Biodegradable bags are sold at most home improvement stores. Woody waste may be considered contaminated if it is bundled with anything other than twine or is mixed with other types of solid waste. Contaminated woody waste would then have to be considered municipal waste and would require disposal at the incinerator. This of course would defeat the benefits of recycling woody waste.
- Material should be one quarter to three inches in diameter.
- There is no limit to the number of "qualifying" bundles or bags that can be placed out for collection.
- NO TRIMMINGS IN GARBAGE BAGS OR CANS.
- NO GRASS CLIPPINGS.
- NO TREE STUMPS.


#### Did you know....

- Rain Barrels are an effective and efficient tool for conserving rainwater and managing rainwater runoff.
- Installing a rain barrel is an easy and low-cost way of collecting and reusing rainwater.
- Rainwater captured from your roof can be used for washing your car, watering your lawn, irrigating your garden, washing lawn furniture and many other activities.
- Using rainwater to do these things can save you money by reducing the amount of water you are consuming through your public water system.



Why use Rain Barrels?

- Rain Barrels conserve water and help lower costs (a rain barrel can save approximately 1,300 gallons of water during peak summer months).
- Rain Barrels reduce water pollution by reducing stormwater runoff, which can contain pollutants like sediment, oil, grease, bacteria and nutrients.
- A Rain Barrels are inexpensive and easy to install.
- Rain Barrels can also be arranged to slowly release the collected rainfall to areas that can soak up the water, reducing stormwater runoff and increasing groundwater recharge.



Rain Barrels with the hardware already installed are available through Windsor Township and/or the Red Lion Municipal Authority at a cost of \$20.00 plus tax. If interested please check with Windsor Township office staff for additional information.

## **Recycling Program**

The restrictions on contamination placed on recycling materials exported to China continue to be in effect. The materials accepted by our recycling program have been reduced. **Only the below listed items are a part of the program.** You can also refer to the flyer contained herein.

#### Acceptable Items:

- Aluminum food and beverage containers with food debris removed. Labels do not need to be removed.
- Glass food and beverage containers with lids and food debris removed: Clear, Brown, Green. Labels do not need to be removed.
- Natural and pigmented plastic narrow-neck containers with symbols 1,2,5 (milk bottles, water bottles, etc.) Lids and food debris removed. Labels do not need to be removed.
- Ferrous (Iron, steel, tin) cans with **food debris removed.**
- Newsprint black and white or pigmented.
- Beverage cartons (milk, orange juice, etc.)
- Corrugated cardboard cut down small enough to fit into the recycling bin.

#### Non-Acceptable Items:

- · Construction paper, craft paper, cereal boxes, shoe boxes, or similar.
- Printer paper, computer paper, copy paper.
- Junk mail.
- Magazines, catalogs.
- Phone books.
- Aerosol cans.
- Window or auto glass, drinking glasses, mirrors
- Light bulbs
- Microwave trays, glass cookware/bake ware
- Plastic bags
- Styrofoam salad/deli containers
- · Household items such as cooking pots, appliances and aluminum foil
- Batteries
- Scrap metal

Wheeled toters with lids are still available for your recycling. The toters are 35 gallon in size and cost \$26.50. The smaller open recycling bins are still available for those who do not wish to purchase one of the wheeled toters. There is a cost of \$10.60 for the open bin.

Just stop by the Township Office during normal business hours to get one. We ask that you paint your street number on the recycling container that you use. The Township will not replace lost, stolen or damaged toters or bins.

**MUST I RECYCLE?** Yes. Pennsylvania law requires all Windsor Township residential and commercial properties to recycle. All recyclable materials must be removed from the regular trash. This is not only the right thing to do environmentally, but it saves money in disposal costs.



As in the past, recycling should not be put out for collection in plastic grocery bags. It will not be collected.

- Hydrogen peroxide




### **BURNING ORDINANCE**

Several significant changes have been made to the Open & Confined Burning Ordinance that the Township wanted to update residents on. The Ordinance has been amended to allow for "Confined" burning within fifty (50') of a building. This pertains to chimineas and similar structures that are less than 55 gallon in size and have a cover to prevent fly ash. The twenty-five (25') setback from adjoining property lines still applies to both open and confined burns. Regardless of whether a "confined" or "open" burn is taking place, residents are required to call into York County Control (911) both prior to the burn beginning and again upon extinguishing the burn. Lastly the Ordinance was amended so the Fire Departments have the authority to enforce the Ordinance and that both the Fire Departments and/or the Police Department have the right to extinguish any burn they feel is unsafe or in violation of the Ordinance. If you have additional questions, please review the Ordinance and/or contact the Township office.

## \*\* WINTER TIPS \*\*

Below are some helpful reminders of municipal regulations and practices related to winter time precipitation:

- Once a Snow Emergency has been declared, all motor vehicles must be removed from all Township streets to allow road crews to properly remove snow from the roads. The Snow Emergency will be announced on the local television stations as well as on our website and facebook page.
- In the past, Snow Emergencies have been declared when significant amounts of snow are being forecasted. We are noticing that more and more cars are being parked on the street during snow events which makes it harder for the trucks to plow. Based on this, a Snow Emergency may be declared more often for lesser snow storm events.
- Please do not deposit any snow onto public streets; this act is prohibited by the Snow Emergency Ordinance.
- Sidewalks must be kept clear of snow/ice within 24 hours after each storm event to provide pedestrian access regardless of whether a snow emergency has been declared.
- If you see that a neighbor hasn't removed the snow/ice from their sidewalk, check with them to see if there are health problems that have prevented the sidewalk from being cleared. If there are health problems, enlist the help of other neighbors to get the sidewalk cleared before calling the Township.



- If you go out of town during the winter months, have a plan in place with a neighbor or friend to remove the snow/ice from your sidewalk.
- If the Township Office receives a complaint that a sidewalk is not cleared of snow/ice, the entire development is checked for compliance. The Township **does not** remove the snow/ice from the sidewalk.
- If you live near or have a fire hydrant on your property, please keep it cleared to allow emergency services to be able to quickly locate and access them in case of an emergency.
- Check your mailbox post to see if it needs to be replaced. As of August 2014, the Township will not compensate property owners should their mailbox be damaged during snow removal.

### **Delinquent Sewer Bills and Water Shut Offs**

Due to the ever increasing amount of properties in the Township that are delinquent on their quarterly sewer bills, the Board of Supervisors entered into agreements with the York Water Company and the Red Lion Municipal Authority to shut off public water to properties that are delinquent on their sewer bills. Any account that has not been paid by the time the next quarterly bill is mailed will receive a notice that the delinquent amount is due within thirty (30) days. If the delinquent amount is not paid in full, water termination procedures will be started.

The water termination process is as follows:

- A ten (10) day notice is mailed and posted at the property requiring **payment in full plus an administrative processing fee which is an additional \$30.00**. Payment must be made at the Township Office by either cash or money order. Personal checks as well as online banking checks will be returned.
- Once seven (7) days have passed and payment in full plus the administrative processing fee have not been paid, a three (3) day notice is posted. Another \$15.00 is added to the amount owed. Again, **payment must be made in full plus the administrative processing fees** at the Township Office by either cash or money order. Personal checks as well as online banking checks will be returned.
- Once eight (8) days have passed and payment in full plus the administrative processing fees have not been paid, a 48-hr. notice is posted. Another \$15.00 is added to the amount owed. Again, **payment must be made in full plus the administrative processing fees** at the Township Office by either cash or money order. Personal checks as well as online banking checks will be returned.
- Once the ten (10) days have passed and payment in full plus the administrative processing fees have not been paid, the appropriate water company is contacted to shut off the water. The cost to shut off and restore water service is a total of \$30.00 for the York Water Company and a total of \$70.00 for the Red Lion Municipal Authority. Again, payment must be made in full plus the appropriate shut off/ restoration fee and administrative processing fees at the Township Office by either cash or money order. Personal checks as well as online banking checks will be returned.

We encourage the payment of the quarterly bill by the due date to ensure that there will be no interruptions of your water service.

If you mail your payment, pay at the Township Office or pay at PeoplesBank, it is important to include the bottom portion of the invoice as it contains your account number. At the least, please write your account number on your check.
